We are the church of above address since 2015. On the 5th May the Meitei Krombhai Tenggal with Meitei Leepun attacked our church had to flee for our lives. They attacked us solely because we belong to Kuki-Zo tribe and want us to stay away from the church.

I am working as Pastor in this church. We left the place, on the same day. We did not bring any belonging with us. We have suffered tremendously and the estimated property lost the Meitei miscreant damage amounted to Rs. 15 lakhs, ~~church~~ Church Altar, Keyboard, Guitar, Music System, sound system, Pulpit etc as well as Guest house, chowkiden house, inside all the furniture and materials.

We have suffered a lot mentally due to this situation. I request you to restore the situation to normalcy and to create us for our loss and book the culprits as per sections of the law.
