Respected sir,

We are the resident of the above address since 2021. On the 3<sup>rd</sup> May 2023 the Meitei Arambai Tenggol with Meitei Leepun attacked our locality and I along with my mother and siblings had to flee for our lives. They attack us solely because we belong to Kuki-Zo tribe and want us to stay away from the valley.

I am a working in Education(S) Department under Manipur Government as Multi-tasking staff. We left for Shillong on 12<sup>th</sup> May 2023 with the help of my relatives. As we came out abruptly we did not bring any belonging with us. We have suffered tremendously and the estimated property that the Meitei miscreant damage amounted to Rs. 30 lakhs, vehicle 2 lakhs, household appliances Rs. 5 lakhs, electronic appliances Rs. 2 lakhs etc.

I have suffered a lot mentally due to this situation. Therefore, I request you to restore the situation to normalcy and compensate me for my loss and book the culprits as per sections of the law.


