Respected Sir,

I and my family were residing in the above address since 15 years. On the 4th of May, 2023, we were ordered to move out of the house by the Arombai Tengol Miscreants or else they threatened that they would kill us. Hence we moved with the protection Police commandos to 1st Manipur Rifles Hq, and next day we flew to Shillong. Once we moved out of the house, on the same day, they burned down our whole house.

I had to flee since I was a Kuki, we still fear for our life. I am doctor at Medical Directorate Imphal and now I don't know when I can go back to my job or if my salary will continue to be paid. I had possessions including electronics, vehicles and jewels worth Rs. 90,00,000/- in my house and my house in itself costed Rs. 3,50,00,000/-, a scorpio vehicle worth Rs. 19 Lakhs and I have no idea if anything is left after the burning down of my house by the mobs.

Due to this incident I and my children have been put to great hardship and mental trauma.

Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy and provide protection for us to go back and re-build our lives back in our locality. We request that you will also protect our properties and the whole locality from encroachment.

We are hoping for Justice for us and for all who are in this situation.
