Respected Sir,

We are the residents of the above address for the past seven years. On the night of the 3rd May, 2023, Arambai Tengol and Meitei Leepun had came and attacked our locality. In the same night, they vandalized and looted all the properties. After which on the next day, they came and burnt the house. When that happened, I along with my family members we ran away and seek shelter at our friends place who belongs to another community. On the 5th May, 2023, the Army came and rescued us and took us to their camp. We stayed in the Army Camp for three days and after that the Army dropped us to Kangpokpi District amd we stayed at the Kangpokpi District Relief Camp. We came to Shillong on the 12th May, 2023 and we are staying at a rented house at Lum Mawpat so that my children can pursue their education. The amount of damages of property which have been lost approx. amounted to 94,55,000. (Ninety Four Lakhs Fifty Five Thousand).

I have been serving in Manipur Police Department for the past 36 years. Because of the ongoing situation, I am not certain of my salary which is important for my maintenance for myself and family. This has put us through hardship and trauma. I and my family were targeted because we are from Kuki Tribe and we no longer have a home to stay and our s=future is uncertain.

Hence, we request you to restore the situation to normalcy and help us get financial help to build my home back, protect my property back in my village from encroachment.

We are hoping for Justice for us and for all who are in this situation.
