

On 04/005/2023 at 9.30 am near NIA Office and CRPF camp.

Respected Sir,

With due respect, I have the honour to state that I am the resident of quarter no=39/II, C-Block, Lamphelpat near NIA Office and CRPF camp, Imphal West District, P/O and P/S-Lamphel, P/C-795004, Manipur.

That on 4th May 2023 at around 9.30 a.m. some unknown miscreants burnt down my quarter No-39/type - II, C-Block, Lamphelpat near NIA Office and CRPF camp, Lamphelpat with criminal intention to cause damage of properties and life.

As a results the quarter and properties worth 5/6 lacs were destroyed, and burnt to ashes and Many properties leftover also were looted on that day.
