With due regards I the undersigned have the honour to state a few lines for your kind consideration and needful action.

That, while I and my family members were staying at my residence located at Kwakeithel Laishram Leikai, IW. On 4/9/2023 at around 3:00 pm, my neighbour Kuki house located at National Game Village, Zone-III near Mary Kom Boxing Academy was burnt down by some unknown miscreants during the ethnic clash between Meitei & Kuki. As a result of the fire my residence's toilet and Western side GI fencing wall was also burnt by the fire. Moreover, the said unknown miscreants had criminally trespass my residence and looted my household material and also partly vandalized my Faith Punto car which was parked at my residence during my absence. The total amount of my damage and looted properties is estimated about Rs. 2,00,000/-. The cause of delaying my report to the concerned Police Station is due to lack of legal knowledge and law & order situation.

Therefore, I request you to kindly take necessary action against the unknown miscreants for their act. Thanking you for your co-operation.
