

Sir,

I have the honour to state that on 04-05-2023 at around 8.30 pm some unknown person forcefully entered our locality Ghari Awang Leikai, Imphal west district Manipur about 5 Km from Lamphel Police Station and they vandalized our quarter and church looted all the moveable and valuable properties including the domestic animals and burnt down our missionary quarter and church along with all the remaining items into ashes leaving us homeless. The cause of delaying my report to the concerned police station is due to lack of Legal Knowledge and law & order situation.

The list of properties destroyed or loss are mention in the Annexure I & II (enclosed) the Approximate value of the destroyed or loss properties is calculated at about Rs. 2,11,9,500./-

It is therefore, requested you kindly register a regular case take necessary legal action against the culprits according to law.
