

Sir,

With due regard, I the undersigned have the honour to state few lines for your kind consideration and needful action.

That today i.e. 19/9/2023 at around 12:48 pm, local youths volunteers and Meirapaibi of both Chingmeirong Mamang and Maning Leikai intercepted a Tata Truck vehicle bearing registration No. NL07AA-1421 coming from Khongnang Ani Karak towards Mantripukhri had detained at Chingmeirong Mamang Leikai opposite to Eastern Auto Agency by the large mob gathered at Chingmeirong Mamang Leikai, alleging to have suspected in trafficking psychotropic substance. On received of the information, myself along with a team of Lamphel PS led by OC Lamphel PS rushed to the spot and managed to rescue both the (driver and co-driver) of Tata vehicle safely from the mob. Due to the vulnerability of the area both the driver and co-driver were brought at Lamphel PS for further verification. On verification, they identified themselves as 1) Bishal Uppreti (23) yrs S/o. Yadav Uppreti of Kalapahar, Kangpokpi District, (driver) and 2) Sushil Thapa (19) yrs S/o. Kamal Thapa of Kanglatombi Tispari. On checking the vehicle at Lamphel Police Station the driver of the vehicle Bishal Uppreti produced 5(five) plastic vial containing suspected to be psychotropic substance, 5 (five) empty plastic vial and Ganja from the rear side of the cabin. Later, the 5 (five) numbers of vial containing suspected to be psychotropic substances are weigh by using weighing machine and found (6.18 gm approx) and Ganja (22.40 gm approx.). A weighing memo has been prepared by observing formalities in presence of the witnesses. Later, suspected psychotropic substances and the vehicle are seized by observing formalities at 2:30 pm and both the driver and co-driver were arrested at 2:35 pm & 2:40 pm respectively by observing formalities.

Thereafter, the seized articles and arrested persons were handed over to Lamphel police station for taking necessary legal action.
