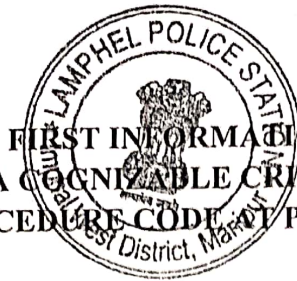

Sir,

Most respectfully, I on behalf of the Manipur State Bharat Scouts and Guides beg to state that the Chowkidar Quarter situated at the campus of Manipur State Bharat Scouts and Guides State Training Centre, Langol, Game Village, Zone-1 has been burn down by unknown persons.

The incident took place on 4/8/2023 night. The quarter was kachha house measuring 600 square feet (20X30) with brick foundation, cement flooring and G.I. sheet roofing, 5 windows, three doors. The approximate extent of lost value including house building and domestic materials is Rs. 10.50/- lakh. (Rupees ten and half lakh) only.

I, therefore, request you kindly to investigate this matter for necessary legal actions against the inconsiderate culprits.
