I have the honour to state that on 04-05-2023
at around 7pm some unknown miscreant belonging to
Meitei Youth of Arambai Tenggal, World Meitei Council
(WMC) Meitei Leipur and Kangleipak Kanba Lip (KKL)

sophisticated weapons entered in my house and
