Sir,

I have the honour to state that, on 06-05-2023 at around 6:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 800-900 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality rented house at Tarung Lamphel Imphal West, Manipur and they vandalised my rented house and looted all the moveable properties and burnt down my house along with all the remaining items into ashes leaving us homeless. The list of properties destroyed or loss are mention in the **Annexure (enclosed)**. The Approximate value of destroyed or loss properties is calculated at about Rs. 6,80,000/- (Six lakhs and Eighty thousand).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
