As a result, my house and properties were destroyed and looted, my house no- CP Quarter Type II-20- Lamphel. Total loss of properties at my residence would be above 25 lakhs approx.

It is therefore kindly requested to take necessary legal actions to arrest the culprits involved in the incident in the interest of justice.

I hereby lodged my complaint at Sapormeina Police Station as I run from my residence to save myself and my families from rioters.
