With due respect, I beg to state that, I. Khatkhosi Misao a residence of Phaipijang Spring Villa, Langel, Imphal West, Manipur house patta no. 3968/3983. Due to the ongoing communal clash between Kuki - Chin - Zo and Meitei community, we have fled from our house on 4th May 2023 timing 11:00 am to save our lives. On 7th August 2023 timing 10:15 p.m., our house was looted by Arambai Lengol, Meitei Lepon and Meiteis of Langel area. In that all our properties have been looted leaving the house empty. They looted worth amount (estimated) of Rs 60,00,000, (Sixty Lakh).

I humbly request you to kindly look into the matter as soon as possible and take necessary action please.
