With due respect, I would like to inform you that during the period between 25<sup>th</sup> May to 28<sup>th</sup> May, 2023, some valley-based organisations suspected to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, broke into my residential house at National Games Village and looted all my household properties. They also vandalized and destroyed and finally burnt down my house which was constructed at the cost of about Rs. 15 Lakhs. The approximate value of my house and all the properties looted is around Rs. 25(twenty-five lakhs) only which includes very important documents and certificates which was kept inside the Godrej (almirah)

I therefore request you to take up necessary legal action regarding the incident.
