**Subject:- First Information report on, looting and burnt down all my properties and house.**

Sir,

I have the honour to state that on 12<sup>th</sup> August, 2023 at around 5 Pm some unknown miscreants belonging to Meitie/meitei Youth of Work Meitei Council (WMC), Meitei Leepun and Kangleipak Kanba Lup (KKL) and especially Arambai Tenggol numbering about 1000 members in all carrying sophisticated weapons like AK Rifles, SLR, 303 Rifles sticks and Iron rod enter our Village Langol Hebron Veng Imphal West, and started ransacking, looting, torching my house.

After looting all the movable properties including house domestic animals and cattle's they vandalised and burn down all the village houses including mine along with my vehicles .The approximate value of properties destroyed estimate calculate at about **Rs. 1 Crore & 8Lakhs.**

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.

I seek your help and kindly request you to register my FIR in the subject matter.  
Hope you will do the needful favourably at the earliest.
