Subject: - **First Information Report on looting and burning down of my quarter.**

Sir,

With due respect, I have the honour to state that, on 15th June, 2023 at around 1:00 PM some miscreants belonging to Meitei/Meetei youths of World Meitei Council (WMC), Meitei Leepun, Kangleipak Kanba Lup (KKL) and especially Arambai Tenggol and also the local populace carrying sophisticated weapons like AK Rifles, SLR, 303 Rifles, sticks, iron rods etc. in large numbers entered our Quarter i.e. **ALL INDIA RADIO COLONY, P.O. IMPHAL MAIN BRANCH, P.S. LAMPHEL, LAMPHELPAT SUB-DIVISION, IMPHEL-WEST DISTRICT** without any reasons started ransacking, looting, vandalised and then burnt down my quarter and all my properties. The list of stolen/burnt down properties are enclosed with approximate value of **Rs. 21,40,000/- (Twenty-One Lakhs and Forty Thousand)** only.

This type of actions towards innocent civilians is totally uncalled for & tantamount to criminal act which call for booking the culprit under appropriate IPC. I therefore, pray that the Culprits may be apprehended and befitting punishment may be awarded under the laws of the land at the earliest. I seek your help and kindly request you to register my **FIR** in the subject matter.
