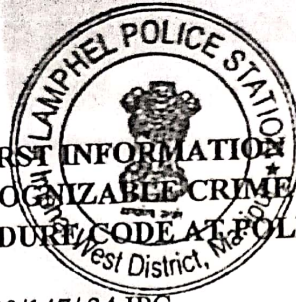



Subject: Complaint of Rioting and Arson in Imphal, Manipur by Mob - Reg.

Sir/Madam,

I am writing this complaint to bring to your attention a heinous crime that has been committed by a violent mob in our locality.

I am a resident of Langol Housing Complex, T-III, E-24, Imphal West, Manipur-795004.

I am also a proprietor of M&N Store, Langol Type-III parking, opposite to Euro Kids Play School, Imphal West, Manipur -795004.

On a fateful evening at around 4:30 pm of 04/05/2023, a violent mob attacked our House, Store and completely vandalized all of our properties. The mob also burnt some houses in our colony.

During the above riots, all of my household items in my residence and all the products in my store have been looted/stolen by unknown miscreants.

The situation was highly chaotic and I was not able to identify the individuals involved in the crime.

However, I have reason to believe that the mob was instigated by certain individuals who have a vested interest in causing unrest in our locality.

We ran for our lives to the neighbour's colony and somehow managed to save ourselves and took shelter at a safer location (Lamphel CRPF Camp), fortunately on time.

I request you to kindly register an FIR against the individuals responsible for the rioting and arson, and take appropriate action against them as per the law. I have attached a list of the damaged and destroyed properties along with this complaint.

I hope that you will take prompt action in this matter and provide us with justice.
