The house comprises of G+3 floors. The mob had broken all the locks, ransacked, looted household properties worth Rs. 50 Lakhs and physically damaged the house.

So, I kindly request you to take action at the earliest against the culprits under relevant sections of the law and under the SC/ST Act, and request for a registration of a Zero FIR as a regular FIR cannot be filed at the place of jurisdiction for reasons of safety and security.
