- That, on 3rd May 2023 at 07:00 pm, a huge contingent of armed Radical Meitei/Meitei Mobs, Arambai Tengol and Meitei Leepun along with State Force like Manipur Police Commando and Indian Reserve Battalion (IRB) Attacked our village, and in the process looted/vandalized/burnt my house/properties.
- That, the above said Criminals with their in humane activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs. 32,50,000 only.
- Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. 3. Henceforth, we are taking refuge at Muolvaiphei Relief Camp, Churachandpur District.

Due to the present law and order situation, I could not submit FIR in time.

I therefore, request you to register an FIR/Zero FIR and bring justice.
