In inviting a reference to the above cited subject, I have the honor to report that on the 4thMay, 2023 at 10 – 11 AM, a belligerent mob of Meitei community (Arambai Tenggol & Leepun) stormed our house at Khongsai Veng colony at state capital Imphal - 795010, Imphal West District, Manipur and engaged in indiscriminate arson, looting theft. Since the incident was very sudden, we had no time to pack anything including personal documents and valuable items nor could we file FIR at a police station earlier. All our properties including cash, jewelries, and documents are looted and burnt down.

Amidst of this violence and arson that spread Manipur extremists have caused damages/loss of Rs. 2,287,500/- (Twenty TwoLakh Eighty Seven thousand and five hundred) only. I therefore request you to take up necessary legal action regarding the incident.
