Subject: Logging of FIR

Sir,

With due respect I would like to state few lines for your kind action and necessary action. That Sir, with the communal tension/violence between the Meitei community and the Kuki community in Manipur that started on the 3rd of May 2023, my household plot at National Games Village, Imphal was also affected. I have purchased the plot of land at Games village bearing Patta No. 127 (old) 2569/3409 (new) at the cost 9(nine) lakhs and planning to start house construction this year (2023). In the month of January 2023, I have purchased building materials which consists of Cements (400 bags) costing approximately Rs. 2 lakhs, Sand (3 truck load of Dimapur sand) costing about Rs. 1.5 lakhs, Iron (16mm, 12mm, 8mm & 6mm) 20 tons costing about Rs. 15 lakhs, binding wire (200 kg) costing about Rs. 20,000/- and other small construction materials which was kept at my plot in a temporary tent. That in the last week of May 2023, I came to learn that all my household construction materials were looted by the Meitei mob. I took loan to purchase all these materials to build a house, however valley-based mobs looted all. The total approximate value of my properties looted is about Rs. 20 (twenty) lakhs only.

In this regard, I requested your good office to registered an FIR and take up legal action against the culprits.
