With due respect I, Nehpu Ex- No.4339029 Assam Regt. PPO No.D/4745/65 age about 78 year s/o (L) Seilhun Haokip a resident of National Game Village Zone-III P.O & P.S. Lamphel, Imphal West presently staying at B.Aijalon P.O.&P.S. Churachandpur will like to state that due to the ethnic clash in Manipur on the 3<sup>rd</sup> May 2023 at around 8:30 pm Meitei miscreant suspected to be member of Arambai Tengol and Meitei Leepun from the valley came and attacked Kuki Houses in the area ultimately burning down our whole property as such we have to fled for our safety from that area.

That, this wanton arson has left us with lots of mental agony and material loss like one storey RCC Building, furniture, kitchen ware etc estimated to be at a value of about Rs.2,90,00,000/-( Rupees Two Crores Ninety Lakhs only). I am filing this report lately after returning from Bangalore at the earliest possible time.

As such I would like to request that your kind office may initiate necessary action at the earliest for the end of Justice.
