That ,on 03/05/2023 around 11:14pm, my four wheeler Alto LXI(O) (silver in colour) bearing registration No.MN01AW9406, Chasis No MA3EUA61S00L48286, Engine No,F8DN6786859,new registration worth about Rs 4,87,0000/- (Rs Four lakh eighty seven thousand) G+10 RCC House plate foundation cost Rs 48 lakh (Rs Fourty eight lakh) Wooden House with CIJ Sheet cost Rs 6.8 lakh (Rs-six lakh eighty thousand) and property worth Rs 2600000(Rs twenty six lakh) including Cash Rs 4.87 lakh (Rs Four lakh eighty seven thousand has been burn into ashes by unknown miscreant in my Present Address - Game Village Zone -1 Private Land Near GVCC Church and building materials like 10mm,18mm, 8mm Rod, and Cement 30 Bags, worth approx Rs 1.6 lakh(Rs one lakh sixty thousand) has been looted from my house.The vehicles is register in my name Holkhanpao Mate S/O Khatngam Mate, Sahumphai-Vill,PO-Sugnu,Dist-Chandel,Manipur.

That it may be also report here that the above said criminal activities have cause mental agony and incurred huge lose which may be estimate to be Rs-92,14000/-(Ninety two lakh fourteen thousand) only.

That iam filling this information lately because there is a great danger to my family life as were as I was posted in Siachen Glacier where there is no proper communication therefore I humbly pray and request you to kindly register a ZERO FIR, investigate the matter and punish the prepratators as per the prevailing provisions of the laws of our country.And for which act of kindness. I shall always remain thankful to you and obliged.
