At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei. On 05-06-2023 at night the lock of my rented quarter was destroyed by public and some person suspected to be members of the Arambai Tengol and Meeitei Leepun, they vandalized and looted all of my properties which were kept in my Quarter worth Rs.13,00,000/-(Rupees Thirteen Lakh) on the said day. I along with my family have to run out from our rented Quarter because the above mention members tried to kill us for being a Tribal and there is no change of being alive in staying at our Quarter.
