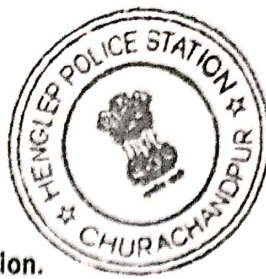

Sir,

With due respect, I the undersigned would like to make a report to your good office about vandalized and looting of our properties (Movable) from my **Quarter at Game Village, Zone IV-B/70 on 05-06-2023 at Night** by public and some person suspected to be members of the Arambai Tengol and Meeitei Leepun.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei. On 05-06-2023 at night the lock of my rented quarter was destroyed by public and some person suspected to be members of the Arambai Tengol and Meeitei Leepun, they vandalized and looted all of my properties which were kept in my Quarter worth Rs.6,00,000/- (Rupees Six Lakh) on the said day. I along with my family have to run out from our rented Quarter because the above mention members tried to kill us for being a Tribal and there is no change of being alive in staying at our Quarter.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future.
