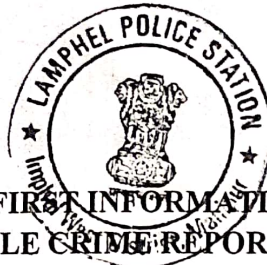

**Subject: Report of breaking locked, criminal trespass by unidentified Meitei family and illegal settling at my official quarter i.e. C.P. Quarter Type – III No. 20 Lamphelpat.**

Sir,

I, the undersigned, T. Chingngaihlian aged about 50 (Fifty) years, D/o: T. Paukham, and currently working/posted as a D.P.O Pherzawl Social Welfare Department, under Government of Manipur and I was allotted C.P. Quarter Type – III No. 20 located at Lamphelpat, Imphal, which consist of 7 rooms in total with extensions.

That, on 3<sup>rd</sup> May, 2023 when the ethnic clash between the Meetei and Kuki-Zomi broke out, there was a manhunt for Kuki-Zomi Tribals by the Meetei Radical groups in and around Imphal area, which compelled me and my family to flee for our life leaving all our belongings behind in my aforesaid quarter under locked and key on 04-05-2023 at around 10:00 AM in the morning. We took shelter at CRPF Camp, Lamphel and were latter evacuated to Churachandpur on the 2<sup>nd</sup> week of May, 2023. I am presently staying at a rental house at Vengnuam, New Lamka, Churachandpur and remains so till date.

That, recently, one of our neighbour belonging to another community not targeted by the radical meiteis near my aforesaid quarter informed me that my official quarter which I have locked under lock and key was broken by some unidentified Meiteis's. Since then, they have been occupying my said quarter without any lawful authority till date. It is pertinent to mentioned herein that while leaving my said quarter behind on 04-05-2023, all our family belongings such as 3 beds, fridge, television, washing machine, gas stove, cylinder, kitchen utensils, sofa set, mattress, dining table, almirahs and other household goods along with a newly constructed Garage was also said to have been occupied which is estimated to be about Rs. 20 lakhs.

I, therefore would like to request your office to take necessary action against those illegal trespassers as per the provision of law and for committing atrocities against me and my family belonging to a Schedule Tribe as per law at the earliest for the ends of Justice.
