Lamphel Police Station FIRST INFORMATION REPORT ON DESTRUCTION AND PROOFING OF Subject-MY HOUSE AND ALL PROPERTIES IN IT

Sir,

- I have the honour to state that on 12 June 2023 around 06 pm, some unknown 1. miscreants/mob belonging to the Meitei community numbering about 200 members carrying sticks, iron rod and Dao entered my house located at Meitei Langol (Pata No 42 (old), 211/852 (new) covered by C.S. Dag No 1134/1611 of 91 Meitei Langol) and carried out massive destruction to my properties in all the three floors (G+2) after breaking in through the doors. The list of my looted and destroyed properties are shown in Appendix 'A' with approximate value of Rs. 46,32,000/- (forty six lakh thirty two thousand).
- The motive behind this destruction is not exactly known but it is also an attempt to murder any family member of the house if present during the attacks.
- Such gruesome attack and barbaric act of the mob with intention to kill members residing in my house and destruction and looting of properties is highly condemnable and tantamount to criminal act which calls for booking of the culprits under appropriate section or
- I therefore, request the authorities to apprehend the culprits and befitting punishments be awarded as per law of the land at the earliest.
- Seeking your help and kindly request for the registration of my FIR in the subject 5. matter.
