Complaint against House trespass, House breaking and stealing of household properties by some groups of unknown miscreants during the current crisis of Manipur (i.e. aftermath of 3rd May, 2023) at my Quarter resident of House No. A/77, Zone III, NGV.

Sir,

With due respect, this is to inform your good office that my quarter/residence at Games Village, Quarter No. A/77, Zone – III has been ransacked and many household & personal properties were stolen by way of House Trespassing, House Breaking and damaging the front door by some groups of unknown miscreants during the current crisis (situation like communal riot/civil war since 3rd May, 2023) of Manipur which is still prevailing.

I could not report about the incident on time because me and family members have all left the said quarter (since 05-05-2023) in order to escape the crisis and we came to know only in the first week of June, 2023 about the housebreak. The following are the some of the details of the stolen Items/articles from the said Quarter:-

- 1. 1(One) Sofa Set;
- 2. 5(Five) Blankets;
- 3. 2(Two) Gas Cylinders;
- 4. Dinner set
- 5. Dining Table set
- 6. All Kitchen materials like Gas Stove, 2 Cutlery Sets, 2 cup sets, glasses and cooking utensils -cookers and curry pots etc;
- 7. All wearing apparels from 2(Two) Almirahs and all clothes from the children's wardrobe
- 8. Some pairs of shoes numbering around 14(Fourteen) pairs including uniform shoes of our 4(four) children and 2(Two) pairs of adult sneakers.

9. 1(One) Large Cotton Bag containing clothes and money bag which contains Rs. 20,000/- (Rupees Twenty Thousand) only.

I have also written an application (on Dt. 05/06/2023) before the O.C. Lamphel P.S. for removing/taking out the remaining properties from the said quarter, but I could make/submit the present complaint regarding the stolen/damage of properties due to want of details of the properties and now I could not travel down to the concern Lamphel P.S. to submit the present complaint for security reasons as we are now station/staying at Senapati and for which we are approaching your good office to do the needful.

Therefore, in the given facts and circumstances your good office is requested to kindly process necessary action and book the offending person/party(s) at the earliest.
