We are the residents of the above address since 32 years and have been staying on a rented house. On the 3th May, 2023, roits began in Imphal and finally got to our locality on the next day. At around 10:00 AM we had to flee our house to seek refuge at the nearest army camp leaving everything behind since the Meitei mob were just few minutes away. We stayed at the camp till the 9^{th} of May and left Imphal with the help of the army convoy for Churachandpur. But, we had to consider the education of our children and had to leave for Shillong thereafter.

The Meitei mobs came and attacked us because we are from a particular community. All our assets and properties which we have left behind in our hometown were destroyed and vandalized
