Respected Sir,

I am resident of the above address since 1987. On 3rd May, Meitei mobs attacked our locality, burning churches and houses. On 4th May, our church "REFORMED PRESBYTERIAN CHURCH, LANGOL" was burnt down along with our Pastor's Quarter. We were told to leave so we took refuge in our neighbour's house carrying my bed-ridden father since our locality was still under attack. At dawn at 4.00 am on 5th May, we were taken to CRPF Camp, Lamphel where we spent the night. Even there, the mob burnt down all the vehicles belonging to Kuki-Zo-Hmar tribes. We booked a flight ticket to Guwahati for 9th May 2023 so we were taken to Imphal International Airport by escort on 6th May. Due to the deteriorating condition of my father, the Airport Authority arranged to prepone our flight ticket to 8th May. We reached Guwahati on 8th May and stayed for a night there and then reached Shillong on 9th May 2023.

I was targeted because I am from Hmar Community and a Christian. Presently I don't feel safe about going back to my home because there is no safer place to take shelter and our life is at stake. I have a property worth 90 lakhs. I have a Santro car and Suzuki Access 125CC in Imphal which were looted by the miscreants. Kindly ensure that our life and property are safe so that we may resume our official duties in a safer zone.

We are hoping for justice for us and all our people from this situation. Yours faithfully,
