We are the residents of the above address since 2015. On the 3rd May, 2023, around 9:30 PM a group of Meitei mob attacked the locality where we lived. A group of volunteers within our area formed a group and defended our area. Since from that night the situation still tensed and there is no normalcy prevailed within the capital city of Imphal. We had to flee for our life on that very morning of 4th May, 2023 and took shelter to the CRPF Camp Lamphel. After that we were escorted from CRPF Camp to Airport, Imphal on the 6th May and took a flight on 10th May, 2023 and reached Shillong at around 4:00 PM on that day itself.

The Arambai Tengols and Meitei militants attacked us because we are tribals. I am just a housewife and I have two children.

We have lost of properties and assets by the mob who came and attack our place which was amounted to Rs. 5 Lakhs Rupees. My possessions which were inside the house was 5 Lakhs. More than that, we have one four wheeler Maruti Omni Van which cost around 1.2 Lakhs and one two wheeler TVS Jupiter which cost around Rs. 20,000 {Twenty Thousand}

Hence, we request you to restore the situation to normalcy and hope that the best solution from my side is separate administration. We could no longer live together with people who are thirsty to kill all the (Kuki-Hmar-Zo) tribes.

We are hoping for Justice for us and for all who are in this situation and to book the culprits as per sections of the Law.
