Respected Sir,

We are the residents of the above address since 34 years. On the 3<sup>rd</sup> May, 2023, around 10:00 PM, around 40-50 Meitei militant came with knives, iron rods and personal-made petrol bombs to chase us out of our residences fearing for our lives, we ran into into nearby CRPF camp Lamphel where we stayed for 11 days and 10 nights. Since we fled with only the clothes we were wearing at the time of escape, we were still wearing those clothes till we flew out of Shillong on 11<sup>th</sup> May, 2023 with the help of tickets.

The Meitei Tengols and Meitei Leepun attacked us because we are tribals. I am abank employee and I have two children. We have lost of properties and assets by the mob who came and attack



our place which was amounted to Rs. 54,43,000(Fifty- Four Lakhs Forty-Three Thousand) Rupees. More than this, we have lost two vehicles which cost around Rs. 2,50,000(Two Lakhs Fifty-Thousand) Rupees.

Hence, we request you to restore the situation to normalcy and punish the miscreants responsible. Find a way for us to gain back what we have lost and a safe place. For us to call HOME.

We are hoping for Justice for us and for all who are in this situation and to book the culprits as per sections of the Law.
