The next day we ran out and entered into a nearby CRPF Camp. We heard that our house was vandalized and the mob took our belongings and who returned back searching for us. On the 11th May, 2023, my relatives booked tockets for us and we reached Shillong.

The Meitei mob attacked us because we are tribals. My children are also with me inShillong seeking shelter. We have lost of properties and assets by the mob who came and attack our place

one scooty which was 90,000(Ninety Thousand) Rupees.

Hence, we request you to restore the situation to normalcy atleast get back our loss property.

Living in a place without security is unimaginable so we want justice. We also want security for our family members. I would like to aloof myself from the community who have cause us nightmares and live separately from them where my family will be at peace and my children would receive education.

We are hoping for Justice for us and for all who are in this situation and to book the culprits as per sections of the Law.
