My son is working as Assistant Audit Officer and my daughter inlaw used to work in the secretariat and both are unable to work anymore and is unsure about their future. They have no idea if their property is still standing or it is burnt down.

Due to this incident I and my children and grand children have been put to great hardship and mental trauma.

Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy and provide protection for us to go back and re-build our lives back in our locality. We request that you will also protect our properties and the whole locality from encroachment.

We are hoping for Justice for us and for all who are in this situation.
