I am resident of the above address since last 1980. On May 04th at around 8.00 am in the morning a mob from Meitei community started attacking and burnt our local neighbours' house carrying various weapons. We felt that we were not safe anymore so we were compelled to take shelter at the near by CRPF camp 86 BN for our life and we stayed there till 11th May on the same day we were escorted by the CRPF to the Airport at Imphal and we came to Shillong, Meghalaya.

I am going through a lot of mental stress and emotional trauma as all my life savings and property is at risk. I was living in a state government quarter and I have plot in airport road which has a size of 1 Sangam. I am afraid that the miscreants will encroach my land.

I was targeted because I am from Hmar Community and a Christian. Presently I don't feel safe about going back to my home because there is no safer place to take shelter and our life is at stake.

We are hoping for justice for us and all our people from this situation.
