Respected Sir,

We are family of 6 members and we are the residents of National Games Village, Zone 1 (B-363), Manipur 795004 . On the 3rd May, 2023, at around 8:00 pm, we heard war bells followed by loud blasts. we, at around 9:00 pm were attacked by the Meitei radical groups so called Arambai and Meitei Leepun. So, in order to save our lives we escaped with our relative's vehicle and took shelter in CRPF 143 battalion, Lamphei and flew from Imphal airport to Guwahati on 12th May and went directly to Shillong.

It was clear that the Meitei mob had attacked us with the help of Arambai Tenggol merely because we are Kuki tribal Christians.

I have property in the house worth 9 lakhs including a Honda Activa Rs 1 Lakh and possessions in the shop worth 25 lacs rupees. The mental trauma has been deep and agonizing as any sound triggers panic attack and sleepless nights follow me to this day. I wish I could someday have a full night's sleep. I am afraid that my property and the possession have been destroyed or looted by the miscreants.
