
Respected sir/mam,

We are the residents of the above address since 30 years and my stepmother was in the house on 3rd of May when the Meitei mobs came in to destroy our locality. Seeing the destruction of my locality and the people belonging to Kuki tribe fleeing, my mother had to flee to the CRPF camp in Lamphel and then later on she was moved to Shillong.

My mother and we are going through a lot of mental trauma as we don't know when can we go back to our house. My house was constructed with all the earnings of my life and is a fully furnished house. Every day I am hearing that people are trying to vandalise and rob my house and the houses in my locality. So we are afraid.

Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy and provide protection for us to go back and re-build our lives back in our locality. We request that you will also protect our properties and the whole locality from encroachment.
