Respected Sir,

We are the residents of the above address since 2008. On the 3rd, May, 2023, the miscreants came to the locality with sticks and knives to attacked the people. On the next day, the 4th May, 2023, Around 4: 00PM, the Meitei Leepun and Arambai Tenggol came with weapons came to locality and stormed all the houses in the locality. They threw petrol bombs at houses. After which, one of my son named, L. Seiginlen Khongsai, aged 15 years old, was shot by the Arambai Tenggol and Meitei Leepun from his right hand while he was defending for his family. After one or two hours, Assam Rifles they came and took my wonded son to RIMS. Because we heard that we were not even safe in the hospital since the Tenggols and Leepun would come and search for Kukis in the hospital, we seek help from our Muslim brothers and they helped us to take my wounded son to Christian Hospital in Deulahlane. On the same day, my brother came to the hospital and took the whole family to IGR Relief Camp and stayed there for one night. And left for Kangpokpi Relief Camp on the next day and stayed there for one night. After which we went to Dimapur by vehicle and left Dimapur and went to Shillong by road. My son is currently under treatment in Supercare Hospital in Shillong.

My properties which were being damaged by the miscreants amounted to Rs. 14,00,000(Fourteen Lakhs) Rupees

Hence, we request you to restore the situation to normalcy and help us get financial help to build my home back, protect my property back in my village from encroachment.

We are hoping for Justice for us and for all who are in this situation.
