## Respected Sir,

I and my family are living in the above address since Fourteen years. On 4th May we got attacked and our house was vandalised and burnt down by the Meitei mobs who were armed and these arms that they had looted from IRB. We had no choice but to flee and hence we went along with Army officials to Leimakhong Army camp for 2 weeks. Then we moved to Shillong ARC Relief Camp. Due to the sudden attack we weren't even able carry a pair of spare cloths nor things for our basic needs.

I know that my house was targeted because we belong to the Kuki tribe and were surrounded by Meitei's. Living in the camp with no idea about our future is traumatising for me and my family. My husband serves in the army since 22 years and all his hard earned money is burned to ashes.

Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope right now. Our house had costed us Rs. 1,30,00,000/- and had household items worth Rs. 9,00,000/-. My daughters who were studying in school can no longer go back to schools as the school has also been burned down as the owner belonged to the Kuki tribe and hence their education has been disrupted.

Hence, we request you to restore the situation to normalcy and help us get financial help to build our home back and protect our land from being encroached and return back to our lands.

We are hoping for justice for us and all our people from this situation.
