Respected Sir,

We are the residents of the above address since 13 years and have been staying on our rented house. On the 3rd May, 2023, around 8:00 PM, an angry mobs with Arambai Tenggol, Meitei Leepun and neighboring locality had attack our locality Paiti Veng, Imphal and my residence(rent) was looted, destroyed and burnt down all our properties. On that night even the state police were also involved in the looting and burning churches, houses and vehicles. The next day(4th May, 2023) we left Imphal to Shillong through flight (Indigo).


The Meitei Tengols and Meitei Leepun attacked us because we are Kuki-Zo ethnic and their pre-planned of ethnic cleansing. I am working as an Accountant at Lee Faith School. I have three children. We have lost of properties and assets by the mob who came and attack our place which



was amounted to 72,38,246(Seventy-Two Lakhs Thirty-Eight Thousand and Two Hundred Forty Six).

Hence, we request you to restore the situation to normalcy and separate administration for the tribals(Kuki-Zo) for long lasting peace, and also compensate the damaged worth by the miscreants.

We are hoping for Justice for us and for all who are in this situation and to book the culprits as per sections of the Law.
