Respected sir/ma'am,

We are the resident of the above address since 2007 . on the 3<sup>rd</sup> of may, 2023 The arambai tenggol along with Meitei leepun, commando, and state forces around 8:00 pm ambush our locality with knives and guns. They shouted all kukis should be killed. I along with my family members 9 of us where inside our house. We hide our kids under the bed along with blankets so that they do not notice us. They started vandalizing our outside house our main gate. I along with my friend put an iron bar so that they cannot come inside the gate. Later they came back to vandalize and look for us . By that time we had off all the lights and hide at the back side of our house. Around 1:00pm the crpf and assam rifles came to evacuate us from our locality to the relief camps.

I am a social worker posted at kotlen. And my husband is an Narcotics OC. We have 6kids. And now due to this conflict and issue I am unable to report to my work and my childrens are not able to attend their schools and classes.

On the 4<sup>th</sup> may after we left our resident, they came back and looted our belongings. Our estimated properties that we lost amounts to Rs- 50,00000. All our valuable documents have also been misplaced. Our vehicles worth Rs 21 lakhs, 3 bicycle for gear worth Rs 35000. Electronic appliances worth Rs- 4lakhs. Were all looted.

I along with my family are deeply traumatize with the incident that happen to us. We believe we are attacked solely because we belong to kuki. Hench I asked the higher authority to compensate me for my loses. And bring justice for me and my family. And to book the culprits as per section of the law.
