As you are aware, a communal pogrom swept our state between May 03 to 07, 2023, and sporadically spread across the state, leading to a grave loss of life and widespread destruction of personal and public property. Entire villages including homes and places of worship were burnt and razed to the ground. Thousands of persons were forced to flee their homes and villages and are now displaced. This violence and arson spread through Manipur, extremists from 3rd May 2023 spread across Manipur attacked the Kuki ZO-Mizo tribe; it was done by some radical sections of the majority valley-based organization namely Meitei Leepun and Arambai Tenggol.

On 4th May 2023, I along with my child and husband had to flee for our lives to CRPF Camp, Lamphel near DC Office due to the brutal violence of the radical mob. We stayed in the relief camp for 1 week. On 11 May 2023 fearing for our lives, we have fled the state of Manipur to another state.

During this violence on 3rd May 2023, our hard-earned properties, movable and immovable assets have been completely looted and destroyed with nothing left for our survival. The incident was so sudden we had no time to pack anything including important documents and valuable items. We have lost our property worth approximately Rs. 17,00,000 (Rupees Seventeen Lakhs only). Below is the list of our properties damaged and looted.
