With due regard, I the under signed have the honour to report to your esteemed Office for further necessary action hereafter.

That, Sir, on the fateful night of 3rd May 2023 at around 9:00 pm, unknown miscreants suspected to be Arambai Tenggol, Kangleipak Kanba Lup and Meetei leepun, numbering about 500 attacked my Quarter No. type II/A-41 at Langol Housing complex under Lamphel Police station, Imphal West District Manipur. Consequently the miscreants broke my quarter and looted all my properties. The value of looted/damaged properties is estimated to be about Rs. 10.00.000 (ten lakhs) approximately.

Due to the prevailing situation, I could not report to my concern Police Station and in due time.

I therefore request you to take necessary legal action against the culprit.
