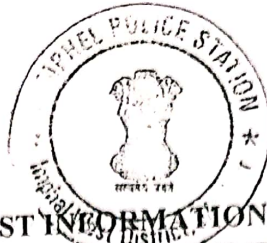

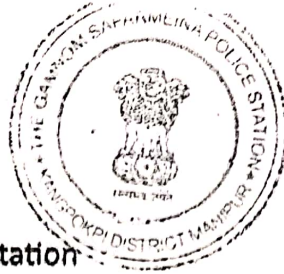

Sir,

With due respect and humble submission, I beg to state that on 04-05-2023 at around 10:00 PM some unknown miscreants armed youth suspected by meeitei Youth organization Arambai Tenggol meeitei leepun and Kangleipak kanba lup (KKL) numbering about 1000 member carrying sophisticated weapons and forcefully entered my colony Langol, PO/PS Lamphel, Sub-Division, Imphal West District, Manipur. Looting all the properties.

The details of properties lost are as follows:

Residential house, Furniture wood (200 KBs), Bend saw (16 inch), Metre saw (12 inch), Jik saw, Planner (2), washing machine, Fridge, Ceiling fan, Smart TV, Sofa set, Bed box, arm bench (6), Single bed, Induction, Gas stove (2), Sintex (4), Cooking metal pot, Godrej Almirah, Wooden almirah (3), Plate set (3), Traditional shawl (32), wooden Chair (4), Plastic Chair (10), two wheller, paddy rice bag 40 and many others.

**The total worth of the properties was estimated to about Rs. 60,00,000 (sixty lakhs)**

I request you to kindly register the case and take necessary action according to law.
