With due respect, I have the honour to state the following few lines for your kind consideration and necessary action.

That, on 6<sup>th</sup> August, 2023 at around 9 a.m some unknown miscreants numbering about 30(thirty) suspected to be Arambai Tengol, Kangleipak Kanna Lup, Meetei Leepun had attacked my Quarter No.CP 20 Type -IV located at Lamphelpat Imphal West District, Manipur and after looting all my house hold properties and occupied my Quarter. The approximate value of properties looted is estimated to be about 6 (six lakhs).

That, I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation.
