With due respect, I beg to state that, I T. Jammilen Chongthu a residence of Gamngaineng, Phaipijang Langol House no. 1 patta no 27/2411. Due to the ongoing communal clash between Chin Kuki Zo and Mitei community, we have fled from our house on 4th May 2023 to save our lives.

On 3rd August 2023, our house was looted by miteis of Langol area. In that all our properties have been looted leaving the house empty.

They have looted worth amount of Rs. 50,00,000 (fifty lakhs).

I humbly request you to kindly look into the matter as soon as possible and take necessary action please.
