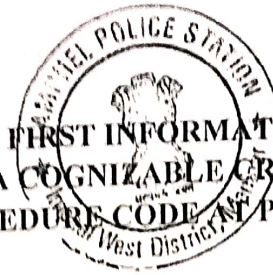

I have the honour to state that, on 9th of May 2023, at around 11:00 Am, the Majority Meitei Community led by Arambai Tengol, Kangleipak Kanba Lup(KKL) and Meitei Leepun attacked my residential quarter at National Game Village i.e. Quater No. Zone-II D/141. Imphal-west and looted all my carpentry machines and wood which were purchase after obtaining carpentry loan from Canara bank bearing A/C 110016364857 of Porompat branch. The approximately value of property looted and destroyed is estimated at about Rs. 5 lakhs.

I could not report the matter to the concerned PS as well as in time due to the prevailing Communal Crisis in the state. Therefore, I request you to kindly take up necessary legal action regarding the matter.
