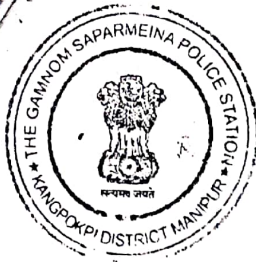

station Imphal west and falling under revenue of Imphal we.
was under mob attacked by thousand of unknown men
belonging to the meitei community with an intent to murder
As a result the my property mention below were
Lost/damaged:

1. 2(100) storey pucca building with pucca fencing, bore in
pump install, iron gate, and three room toilet bathroom,
outside the building in the campus worth ₹ = 15,00,000/-
2. 50 nos of wooden plank worth ₹ = 60,000/-
3. Generator worth ₹ = 10,000/- 4. 3 nos of syntax worth ₹ =
15,000/- 5. 50 bags of cement worth ₹ = 28,000/-
6. 20 nos of tin worth 8000/- 7. Electric good worth
₹ = 20,000/-

Total lost/damaged of properties at my residence would
be above 15,14,000/- (one crore fifty one lakh and four
one thousand)

It is therefore kindly requested to take necessary legal
action to arrest the culprit involved in the incident at the
earliest in the interest of justice.
