

Respected Sir,

We are the residents of the above address since last 9 years. We live in a joint family of 15 members. On the 3<sup>rd</sup> May, 2023, around 7:30 PM. The Meitei mob with Arambai Tengol came and attacked our locality searching for Christian Kukis. We closed our doors and windows and turned off our lights. We were so afraid that we did not make any noise and we kept hidden in our quarter. Next morning, we fled to CRPF Camp in DC Office. From CRPF Camp we came to Shillong by flight which we boarded from Imphal Airport.

The Meitei mobs attacked us because we were Kuki Christians. I am a housewife. I have two small daughters who are still studying.



I am afraid that my properties worth Rupees 1645000/- approximately has been destroyed/ looted by the Meitei miscreants.
