Respected Sir,

We are the residence of the above address since 19 years in my plot of land at the Address mentioned above.

That, due to my service, I am currently posted in Shillong for over 15 years. Yet, I too have been a victim of the current violence which took place in Manipur since the night of 3rd of May, 2023. My relatives (Mr. Lianboi Gangte & Family) were staying in the two houses I own at the Address mentioned above but on the 4th May they had to flee from the house for safety leaving all properties behind and take shelter at the IG Assam Rifles South Campus at Imphal.

Later, we learned that all the properties inside the houses were looted and both the houses vandalized/destroyed.
